Carries out import, export, production, wholesale and retail sale of oceanic and freshwater fish, red caviar, seafood; fish semi-finished products; salted, smoked and dried freshwater and sea fish. The group uses the latest technological base and introduces new technologies into the production process; the production uses the equipment of the world's leading manufacturers.

List of production complexes: The group of companies has the following production complexes:

- Production complex for processing fish products, total area before the war: 8,551.1 sq.m., currently restored 5,607.1 sq.m;
- Workshop for processing fish products, total area before the war: 3,349.80 sq.m., currently restored 1,933.40 sq.m;
- Fish and seafood processing workshop, total area 692 sq.m.

In 2022, both facilities were partially damaged by attacks by the Russian Federation. Currently, production has been fully restored and logistics capabilities (warehouses) have been partially restored.
