## Concept

#### CONCEPT/SUMMERY

The European and Euro-Atlantic integration is a cornerstone of Georgia's foreign policy. The Government of Georgia is making its utmost to deepen EU-integration related reforms.

The EU-Georgia Association Agreement, including the Deep and Comprehensive Free Trade Area Agreement (DCFTA) was initialled at the Eastern Partnership (EaP) Vilnius Summit on 29 November 2013 and is expected to be signed by August 2014, before the expiry of the term of the current European Commission.

The signature of the Association Agreement will bring the EU-Georgia relations to a historically unprecedented, qualitatively new level of cooperation and will represent a significant step towards further political association and economic integration with the EU.

The Deep and Comprehensive Free Trade Area Agreement is an integral part of the Association Agreement, which implies liberalization of trade of goods and services, as well as approximation of Georgian trade-related regulations and institutions with the EU norms and standards.

The establishment of the Deep and Comprehensive Free Trade area between the EU and Georgia will facilitate:

- Formation of the EU compatible trade system;
- Creation of attractive investment environment and consequent encouragement of foreign investments;

- · Creation of new jobs through stimulation of foreign investments;
- Increase of competitiveness of Georgian products;
- Increase of Georgian export;
- Improvement of quality of Georgian products;
- Stimulation of Georgia' economic growth and economic development in general.

- Raising awareness among governments and private sectors of the EU and the Eastern Partnership countries about Georgia's economic policy, business environment and investment opportunities;
- Increasing visibility of successfully implemented reforms in the framework of the Deep and Comprehensive Free Trade Area Agreement;
- Sharing experience with partner countries regarding economic reforms and the economic integration with the EU;
- Discussing the post Vilnius Summit economic cooperation trends among the EU and the Eastern Partnership countries;
- Facilitating business to business contacts;
- Sharing best practices between representatives of the Georgian and the EU business community regarding implementation of activities related to approximation with the EU regulations;
- Strengthening regional dimension of economic cooperation.
