



**EU Information Day - Transport Infrastructure Opportunities in Montenegro,
Podgorica, 28 January 2025 – Second call**

Your Excellency,

The Government of Montenegro and the European Commission, in cooperation with the European Bank for Reconstruction and Development (EBRD) and the European Investment Bank (EIB), invite you to an Information Day on Transport Infrastructure Projects in Montenegro.

The objectives of the Information Day are:

- To present the ambitious investment programme (approx. €9billion) for transport infrastructure development planned by the Montenegrin Government, and the great opportunities this opens for investments and partnerships in Montenegro and the Western Balkans Region.
- To present the upcoming roads infrastructure tenders to be launched along the TEN-T Corridor IV, in particular the segment Matesevo – Andrijevisa which is about to be launched.
- To explain the prevailing investment conditions and reforms undertaken on its way to the EU, making Montenegro a very interesting and safe place where to do business;
- To connect Montenegrin and regional construction companies with EU Member State companies specialised in transport infrastructure development.
