Slovenia to launch a tech accelerator program for Slovenian startups in Israel.

This high-end 2-month program was jointly set up by the **Slovenian embassy in Israel, Spirit Slovenia, the Slovene Enterprise Fund** ,and will be managed by Arieli Capital's ETC.

About 10 startups will be exclusively selected to take part in the first accelerator program for Slovenian startups in Israel, a two-month program that will start February 2022 and take place in Tel Aviv, one of the world's leading ecosystems for startups.

The 10 startups will be chosen via a tender process published starting December of this year and will stay open until mid-January 2022. (or sooner, once the startups have been approved, based on program conditions). The program is open for startups from a variety of sectors including health, agriculture, fintech, smart mobility, food tech, cleantech, and more who are seeking to accelerate their startups and grow through this unique opportunity to connect to the heart of Israel, known as the Startup Nation.

The Accelerator program will take place in Tel Aviv, the heart of the Israeli startup ecosystem. The Accelerator program will start at early February and will end early April, 2022.

The Accelerator will be led by Arieli Capital's ETC, which operates innovation centers and programs for leading academic/research institutions, governments, municipalities, industry brands, and investment/capital funds including: Italy-Israel Accelerator, Italian government, Intesa San Paolo bank, Amadeus, EIT, Frontier Innovation Center, Eilat technology center hub, Bridge USA Wellness Accelerator, Microsoft for Startups and more.

The main objective of the program is to connect Slovenian companies – with an emphasis on start- ups operating in the high-tech sector that has successfully verified their products in target markets, addressing an important problem of the target group of users – with a foreign investment ecosystem.

The objective is also to provide participating companies with the knowledge and information to help them optimize their business, legal and financial strategy and connect them with potential partners, customers and investors in the international field.

One of the most important international investment ecosystems, which is at the same time an excellent market for verifying the suitability of new solutions for global markets, is **Israel**. It represents one of the best ecosystems for start-ups in the world, it is highly positioned in the world in terms of the number of start-ups and also of the number of engineers, reaching billions in investment in companies, a large part of which is in the form of support from venture capital funds. The Israeli economy is extremely experienced in the field of negotiation and presentation skills and it is a useful test market where many foreign companies are present, which is why there is good knowledge of various world cultures in this market. It is a good stepping stone for many companies entering foreign markets. **The program is funded by the Slovenian Government**.
