- ii. Evidence of Company's Income Tax Clearance Certificate for the Last three (3) years valid till 31st December, 2023; with minimum average annual turnover of N20 million
- iii. Evidence of pension Clearance Certificate valid till 31st December, 2024 (this requirements is only applicable to bidders whose number of staff is 15 and above);

xi. Company's profile with curriculum vitae of key staff to be deployed for the project, including copies of their academic/professional qualifications

xii. Verifiable documentary evidence of at least three (3) similar jobs executed in the last five (5) years including letters of awards, valuation/job completion certificates and photographs;

xiii. For joint venture/partnership, a memorandum of understanding (MoU) should be provided indicating among others the lead partner (CAC, tax clearance certificates, pension clearance certificate, ITF compliance certificate, NSITF clearance certificate, IRR & sworn affidavit are compulsory for each JV partner);

Note: documents for submission must be transmitted with a Covering/Forwarding letter under the Company/Firm's Letter Headed Paper bearing amongst others, the Registration Number (RC) as issued by the Corporate Affairs Commission (CAC), Contact Address, Telephone Number (preferably GSM NO.) and e-mail address. The Letter head Paper must bear the names and Nationalities of the Directors of the Company at the bottom of the page, duly signed by the authorized officer of the firm. Note: technical bid should have a table of content and be paginated.
