 - Times New Roman font, 11pt
- The abstracts should include the following additional information:
 - Title of Abstract
 - Author name/Position/Institution/Country
 - Personal Contacts (e-mail, mailing address, and telephone number)
 - The Relevant Conference Topic
 - The Objective of the Paper and its Conclusion

The authors of accepted abstracts will be notified by 10 September 2018 and will be requested to submit their Full Paper and PowerPoint Presentation until 8 October 2018.
