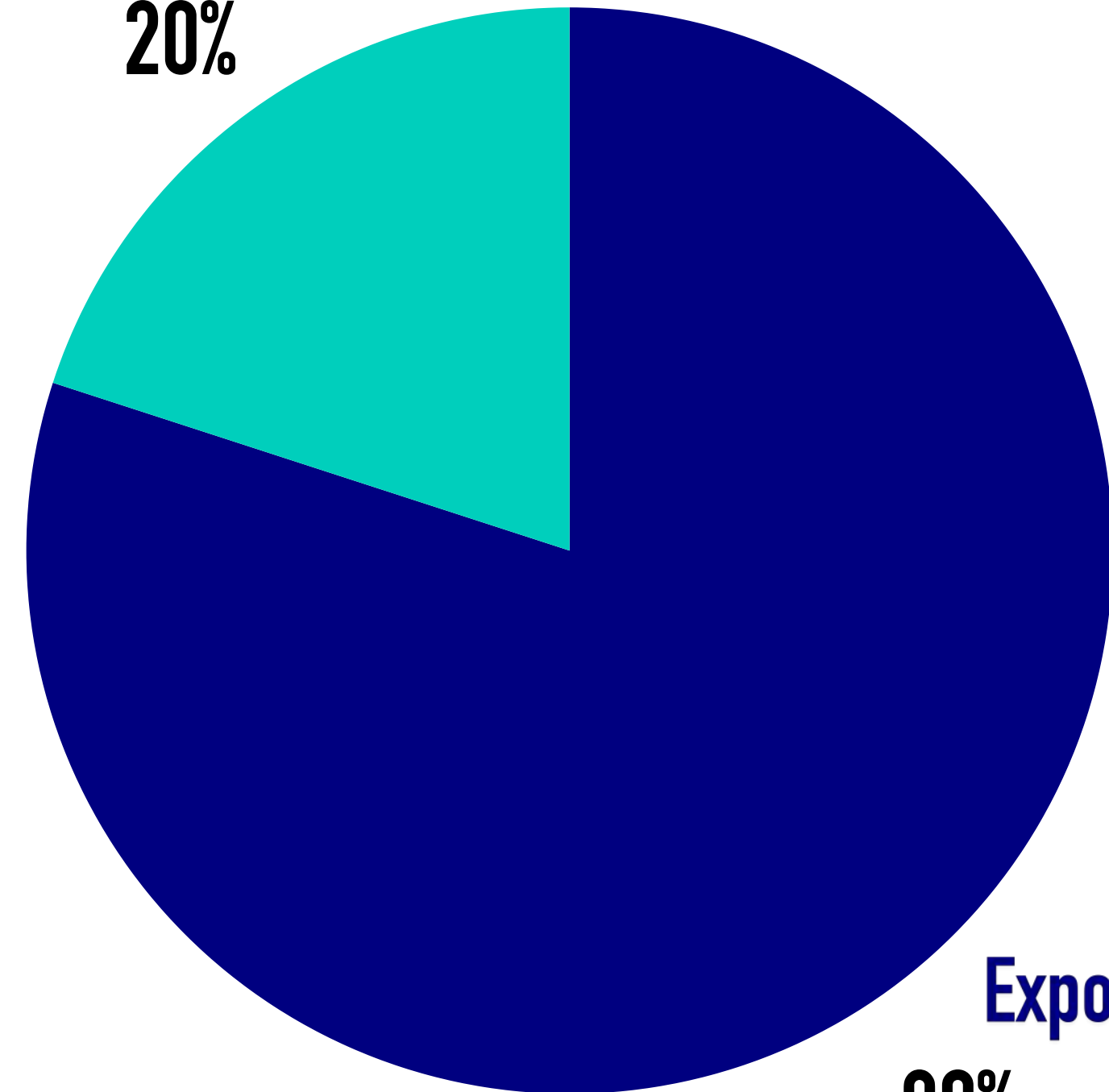
HTP's 80/20 Rule
